





SN54F27 . . . J PACKAGE SN74F27 . . . D OR N PACKAGE (TOP VIEW)




SN54F27...FK PACKAGE (TOP VIEW)

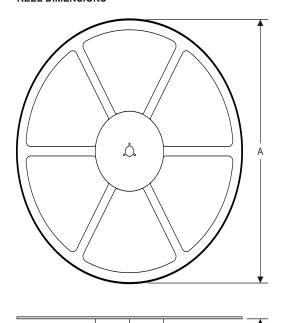

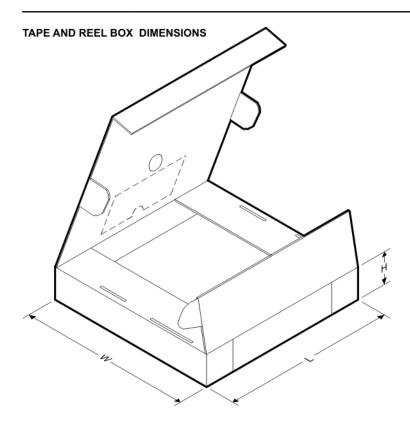
